



# Enrolment Instructions

## CPA UNITS: SESSION 2, 2018

This guide is for students enrolled in Master of Accounting (CPA Extension/ (Advanced) CPA Program/CPA Program) or Master of Advanced Professional Accounting and contains a timeline of important dates and information to assist with your enrolment in CPA units with Macquarie University and CPA Australia.

### IMPORTANT NOTES

- Students need to enrol with both Macquarie University *and* CPA Australia;
- To enrol at Macquarie University, please submit a CPA Unit Enrolment Form via AskMQ (ask.mq.edu.au);
- Please contact CPA Australia directly to arrange enrolment in the CPA Program (Professional);
- Always refer to the CPA Australia website (www.cpaaustralia.com.au) to confirm important dates;
- Enrolment fees will be payable to Macquarie University and CPA Australia separately.

### Important Dates

Date	Task to Complete
Thursday 03 May, 2018	Students attend the CPA Information Session.
From Thursday 03 May, 2018	Students submit a 'CPA Unit Enrolment Form' via AskMQ (ask.mq.edu.au) to request enrolment in CPA units at Macquarie University.
From Thursday 03 May, 2018	Master of Accounting (CPA Extension/CPA Program) students who have <u>not</u> had a CPA assessment should apply for membership online: <a href="https://www.cpaaustralia.com.au/become-a-cpa/how-to-apply">https://www.cpaaustralia.com.au/become-a-cpa/how-to-apply</a>
Tuesday 12 June, 2018	CPA Australia enrolment and exam scheduling opens. Master of Advanced Professional Accounting students contact CPA Australia to enrol in CPA Program (Professional).
Friday 13 July, 2018	MQ exam results released via eStudent. Master of Accounting (CPA Extension/CPA Program) students should contact CPA Australia to update their academic status and arrange for enrolment. <b>(Submit unofficial transcript to CPA Australia first so that you do not miss out on the early bird enrolment, and then provide official transcript for review)</b>  <i>*Go to 'My Results and Graduation' on your eStudent account, and click on 'Email my Unofficial Transcript' to obtain an unofficial transcript.</i>  <i>*For instructions on how to apply for an official academic transcript, please refer to the University website. <a href="http://www.students.mq.edu.au/student_admin/student_connect/transcript_request">http://www.students.mq.edu.au/student_admin/student_connect/transcript_request</a></i>
From mid of July 2018	Students complete Class registrations for Macquarie CPA units via eStudent.
Wednesday 11 July, 2018	CPA Australia early bird enrolment closing date.
Monday 23 July, 2018	CPA unit Classes begin (1 week before standard Macquarie session).
Tuesday 24 July, 2018	CPA Australia final enrolment closing date.

# FAQ: CPA Enrolment in Session 2, 2018

I AM ENROLLED IN MASTER OF ACCOUNTING (CPA EXTENSION) BUT WOULD LIKE TO GRADUATE WITH MASTER OF ACCOUNTING (PROFESSIONAL) AT THE END OF SESSION 2, 2018. IS THIS POSSIBLE?

Students who are admitted to the Master of Accounting (CPA Extension) pre- 2015 can request to graduate with Master of Accounting (Professional) if they complete all units as stated in the 2014 curriculum. An 'I Expect to Complete' form should be submitted online via AskMQ ([ask.mq.edu.au](http://ask.mq.edu.au)).

Students who are admitted to Master of Accounting (CPA Extension) post-2015 and would like to transfer to the Master of Accounting (Professional Practice), please make an appointment to see with one of our Student Advisers. I AM ENROLLED IN MASTER OF ACCOUNTING (CPA EXTENSION), MASTER OF ADVANCED PROFESSIONAL ACCOUNTING, MASTER OF ACCOUNTING (CPA PROGRAM) 2017/2018 OR MASTER OF ACCOUNTING (ADVANCED) CPA PROGRAM-2017/2018 AND WOULD LIKE TO COMMENCE MY CPA STUDIES IN SESSION 2, 2018, HOW CAN I DO THIS?

Students will need to enrol in CPA units with both Macquarie University and CPA Australia. CPA only permits to enrol 3 CPA units in a session.

To enrol with Macquarie University, please submit a CPA Unit Enrolment form via AskMQ ([ask.mq.edu.au](http://ask.mq.edu.au)).

To enrol with CPA Australia, please follow the Enrolment Instructions to have your academic qualification assessed and to enrol in the CPA segments.

*Master of Advanced Professional Accounting students should have already received confirmation from CPA Australia about their eligibility to start the CPA program (Professional). If you have not had your previous qualifications assessed by CPA Australia, please contact them immediately to arrange for an assessment and enrolment.*

WHAT ARE THE RECOMMENDED STUDY PLAN FOR CPA UNITS?

Students are recommended to study ACCG907, ACCG908 and ACCG913 in the first session of their CPA enrolment. The remainder of the CPA units may depend on the degree and curriculum that you are following, therefore you are advised to check the 2018 Program Guides, if you commenced your studies in 2017; and seek program advice from FBE Student Admin (BESS) in 6ER.

If a student passes MQ component but fails the external CPA exam, an Incomplete (UL) grade will be given. Students must re-enrol in the failed segment with CPA Australia in the following session. (CPA Australia allows students to enrol in a maximum of 3 segments per session.)

If the failed CPA exam is an elective, student has the option to change to another elective.

International students who fail one (or two) of the compulsory CPA segments (ACCG907, ACCG908, ACCG913) should enrol in the CPA electives (if no other non-CPA units are available) to maintain full-time study load. Special Approval (waiver) request will need to be submitted together with the CPA Unit Enrolment form.

If a student has failed the same external CPA exam twice, the MQ Incomplete grade will be changed to a Fail grade.
